- 4. Tell us about a project, activity or cause that this person has been involved in that has made a positive difference for First Nations people and/or the wider Victorian community. Please give specific examples.
- 5. What do you consider to be this person's legacy? What will be their lasting impact on First Nations communities and wider Victoria? Please give specific examples.

- 1. **Inspirational role model:** demonstrates qualities that inspire both First Nations and non-First Nations people in Victoria
- 2. Commitment to First Nations culture in Victoria: shows dedication to preserving and promoting First Nations traditions, culture and values
- 3. **Community Impact:** shows commitment to achieving practical outcomes for First Nations people in Victoria, or about First Nations issues for the wider community
- 4. **Leadership:** demonstrates leadership that achieves positive change and outcomes for First Nations people in Victoria, on First Nations issues in the wider community, or specifically in government, enterprise or the not-forprofit sector.
